What is a School Board?

Definition of Effective School Boards (source: California School Boards Association (CSBA) https://www.csba.org/en/About/AboutCSBA/MissionAndVision?p=1

CSBA recognizes that educational excellence requires a commitment to equity. California students bring a wide range of assets, abilities, backgrounds, and needs to their educational experience. Schools have an obligation to provide all students with the access and opportunities necessary for college, career, and life success. This requires school leaders to address practices, policies, and barriers that perpetuate inequities which lead to opportunity and achievement gaps.

Effective school boards are equity-driven, making intentional governance decisions that combat institutional discrimination and bias (both explicit and implicit) and eliminate disparities in educational outcomes based on socioeconomic status, gender, gender identity, gender expression, race, religion, national origin, ethnicity, sexual orientation, disability, or family background.


Citizen oversight of local government is the cornerstone of democracy in the United States. School board members are locally elected public officials entrusted with governing a community's public schools. The role of the school board is to ensure that school districts are responsive to the values, beliefs and priorities of their communities. Boards fulfill this role by performing five major responsibilities:

- Setting direction
- Establishing an effective and efficient structure
- Providing support for Superintendent and Staff
- Ensuring accountability
- Providing community leadership as advocates for children, the school district and public schools

Authority is granted to the board as a whole, not each member individually. Therefore, board members fulfill these responsibilities by working together as a governance team with the superintendent to make decisions that will best serve all the students in the community.

In California, there are approximately 1,000 school districts and county offices of education that are governed by more than 5,000 school board members. California's is the largest public school system in the nation, serving more than 6 million students — a collective student body larger than the total population of many other states.

Briefly describe:

• your educational philosophy.

- As a board trustee, students are the priority. My guiding principles are that these students deserve:
 - an excellent education that prepares them for adulthood,
 - a safe environment in which to learn,
 - and financial accountability (how the district is using its resources to benefit its students).
- O Another one of my principles is being an active listener. I have been holding "Office Hours withTrustee Stephanie Leishman," and any student, parent, or teacher/staff can sign up to meet with me. I have been doing many hours of these appointments and I opened more times on my calendar because I was booked solid and because people were thanking me for making time for them. I have enjoyed meeting so many people who are telling me about their experiences with the schools in the Nevada Joint Union High School District.
- the responsibilities of a School Board member.
 - The school board as fiduciary, which is why financial accountability is so important. Also, the board hires the superintendent, who then is responsible for the operations of the district. The board sets strategy and vision for the district.
- your professional experience that prepares you to carry out the responsibilities of a School Board member.
 - I am a Harvard graduate. I worked at MIT for 7 years. Also, I earned two graduate degrees: MBA and MSIS. I have been a student, teacher, administrator, and board member. I have taught and mentored students for many years, including high school students from Spanish-speaking homes. I was able to communicate with parents who did not speak English well.
 - I also have experience with school safety. I served on MIT's emergency response committee when the
 university experienced a shooting, chemical spill, blizzard, fire, and suicides. I was instrumental in advising on
 emergency response in this digital era. I have FEMA certification in emergency response, and I have used this
 knowledge extensively here in California through many wildfires. I currently lead a committee that oversees
 emergency response for several church congregations throughout Nevada and Placer counties, covering
 thousands of households. I have been through several emergencies (including wildfires) in this role and have
 honed our approach over the past few years.
 - I have been meeting regularly with the school district's chief business officer. I ask questions. I look for trends in spending and where the district might be overspending. I also seek to understand who the vendors are and how the district takes care of its facilities. I have done many school campus tours with the district

facilities director. I have a Master of Business Administration, I am a business owner, and I have been a nonprofit treasurer. I have negotiated corporate leases in such a way that the non-profit paid less than their maximum willingness to pay.

 - NJUHSD's curriculum committee (made up of teachers, principals, and other staff) discusses and selects curricula. Curriculum choices must meet state requirements. These choices are then brought to board meetings and included on the agenda.

 I believe students should learn our country's history.
- Do you believe the School Board should be involved in staffing decisions?
 - The one hire the board makes is the superintendent. The superintendent then makes staffing decisions when it comes to principals, teachers, and classified staff. However, personnel changes do come to the board for review. Much of the hiring and firing process is procedural and the district must follow the California education code as set forth in California law. So, when the board makes a vote, you will find that often it is because there is a law in place requiring that oversight.

Briefly describe:

- your educational philosophy.
 - All students have different types of skills, talents, and needs, so we need to have a robust college readiness program along with a vocational ed program that is just as robust. All parents know that each of their children have different strengths. This allows us to tailor our schools to help each student based on where they are. As well, students need to feel physically and emotionally safe while they're at school. No learning will take place if a student is worried about their safety.

• the responsibilities of a School Board member.

• A trustee's responsibilities include passing policies that are consistent with California Ed Code to operate public schools and making sure those policies are carried out. Also, informally, in my opinion, they are to attend school events in a leadership capacity to promote goodwill and support for public schools. It shouldn't be about attending a meeting once a month.

• your professional experience that prepares you to carry out the responsibilities of a School Board member.

I am a retired high school teacher with 38 years of experience. I was also trained to analyze school district budgets so we can make sure every tax dollar is spent on effective instruction for the students. Also, I was appointed to a state commission on education and served six years. I was the only teacher on the committee, so my responsibility was to serve as the teacher voice for California's 325,000 teachers.

I worked with my local school board to raise teacher salaries so the district could be competitive and hire the best and the brightest to work with our students. Vet As a result, veteran teachers transferred to our district.

• What endorsements have you received?

- I am proud to have received the endorsement of the local classroom teachers. As well, I have received the endorsement of a large group of retired local school administrators which will be announced next week. I have also received the endorsement of Ed Scofield, Area 2 County Supervisor.
- Do you believe the School Board should be involved in selecting specific classroom curricula and/or books for School Libraries?

 No. Classroom curriculum should be selected from the curriculum approved by the state board of education. A committee of grade level educators, the ones who would be using the curriculum, should be formed and led by a school administrator. Libraries should consist of books approved by the state board of education and selected by the school librarian.

• Are there any parts of American History that should be excluded from your School Districts curriculum.

No. Again, books should be selected from the California list of approved history books by the State Board of Education. It is a rigorous process composed of a committee of veteran classroom educators. I do want to also comment from a personal perspective, I taught American History for 38 years at the junior high and high school level. I never heard of CRT until the last two years. 99% of history teachers do not force their opinion on the students. They present the facts as stated in the books and let the students form their own opinions. The most exciting part of teaching history for me was to see each student examine, analyze, and evaluate history and form their own options.

• Do you believe the School Board should be involved in staffing decisions?

Not directly except when it comes to hiring a superintendent. Usually, the Human Resources person will form a committee to interview and hire staff whether it be certificated, classified, or administrative. The Board would then formally approve hires at meetings, but the trustees should trust the hiring committee and follow their recommendations. This helps to avoid charges of nepotism and allows the best and brightest to be hired. Our students deserve that.
